Post-Election Analysis

Last week Donald Trump was elected the 45th United State President. The Republican Party also maintained its control of the U.S. House and U.S. Senate, setting the stage for single-party control of both the executive and legislative branch for the next two years. While many questions still exist as to how this election will effect AHPA hospital systems it is almost certain the Affordable Care Act repeal will happen.

While a repeal of the ACA is essentially a certainty, what it will be replaced with is still ambiguous. President-Elect Trump outlined some pieces of his health care program in brief 310 word plan on his website late last week. Some of the highlights include:

- Repeal and Replace ACA
- Increase use of Health Saving's Accounts (HSA's)
- The ability to purchase insurance across state lines
- Establish High-Risk Pools
- Maximize flexibility for states in administrating Medicaid
